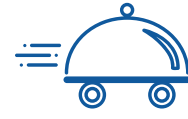

## FINANCIAL REQUIREMENTS TO OWN A GYRO SHACK

Total investment for a Gyro Shack franchise ranges from \$162,500 to \$509,000. Franchise Fees start at \$25,000 for the first location and scale down from there. With each subsequent store in a market, the franchise fee will be reduced by \$5,000 per store down to a floor of \$10,000.
